Mr. Gebo commented that this is a matter of preference for the Town Board and they could choose to offer it or not based on what the priority of the Town Board is. If they wish to encourage solar energy they could offer the exemption.

SUPERVISOR'S REPORT: Supervisor Fleming presented Clerk Greene with a letter from the EFC dated December 22, 2016 and signed by Sabrina M. Ty, President and CEO of NYS EFC and asked that she read it aloud. Clerk Greene read aloud the letter which explained that the Town of Denmark Water District #1 "...is eligible for a Drinking Water State Revolving Fund interest-free financing of \$1,000,000.00 for a term of up to 30 years for the project balance not funded with grant through the NY Water Grant Program." This eligibility will remain in effect through September 30, 2018.

Supervisor Fleming introduced Mr. Scott Doyle, a resident of the Town of Denmark who has expressed interest in being appointed to the Town of Denmark BAR.

She also provided the Town Board with a copy of a letter of thanks from the Riverside Cemetery Associations dated 12/2/2016 for the contribution of \$500.00 from the Town of Denmark.

ASSESSOR'S REPORT: Mr. Vargulick reported that Lewis County has decided to assign SBL #'s to split (sub-divided) parcels. Discussion was held on the difference between assigning SBL #'s and recording deeds.

Mr. Vargulick asked the Town Board to decide on the exemptions for Solar by the time the 6 month Town of Denmark solar moratorium expires. He noted that currently the Village of Castorland and Copenhagen Central School both offer the exemption. He cautioned that in a commercial project the IDA could trump Town Law and grant an exemption. Councilman Der expressed his opinion that the Town Board needs to act on solar prior to the moratorium expiring.

**HIGHWAY SUPT REPORT:** Supt. Mahar discussed with the Town Board the towns need for medicine cabinet supplies and a quote he has gotten from G&K Services for \$11.00 per week to oversee the cabinets. Discussion was held. Budget Officer Fleming will review last year's payments to determine the amount spent.

Discussion was held on the Highway Employees uniforms. Currently in the Teamster contract with the Town requires 2 winter parkas per employee. Additionally they are being provided pants, overalls and shirts. Supt. Mahar recommends that the Town Board consider putting this contract out to bid soon as the current contract expires in March 2017.

Discussion was held on the replacement of the broken Key Boy system on the fuel island. Bach Environmental has submitted an estimate for \$11,750.00 to replace the current system. Discussion was held by Town Board. Mr. Doyle asked if a log was being kept and if the batch inventory vs. usage were in agreement. Supt. Mahar responded that the men were logging use and batch inventories are being logged also. If audited a key system provides further evidence of oversight. Councilman Jones asked where money for this type of repair would come from and Supt. Mahar explained it would be from A5132.4 for general maintenance of the facility.

**OPEN DISCUSSION:** Discussion was held on the current fuel bid between the Town of Denmark and Simpson Fuels. <u>Councilman Jones offered Resolution 11-2017</u>: That the Town of Denmark Pursuant to provisions of the NYS General Municipal Law, Section 103, of the State of New York, the Town of Denmark will receive bids for FUEL: Unleaded gasoline (87 octane), ULS Diesel and Heating Oil to be delivered to the Town of Denmark Municipal Building, 3707 Roberts Road, Carthage, NY 13619. Bidders shall agree to honor the bid amount for twelve (12) calendar months. Prices are to be exclusive of any applicable taxes and shall include delivery.

The bid must include a breakdown of the cents over rack price for each product. Please indicate which rack price depot is being utilized. Unleaded gasoline capacity is 300 gallons and approximate annual usage of 2,800 gallons, ULS Diesel capacity is 3000 gallons approximate annual usage of 25,000 gallons, and heating oil capacity is 550 gallons with approximate annual usage of 7000 gallons. Delivery should be on an automatic basis.

Sealed bids must be received by the Town of Denmark Town Clerk no later than Thursday, February 9, 2017 at 4:00 pm. The bids will be opened at 6:00pm, Monday, February 13, 2017 at the Town of Denmark regular monthly meeting. The Resolution 11-2017 was seconded by Councilman Thoma.

Supt. Mahar noted as a few issues with the snowplows that the Highway Dept continues to work on. He also noted issues with the in floor radiant heat in the garage. The floor is over 13 years old and in his opinion the Town should start to plan for replacement of the pumps.

Councilman Der brought up the issue with setbacks for non owner, occupied residences within the wind project overlay. Currently the Town of Denmark Zoning law requires the signature of owner occupied properties for any variances of setback distances. The law currently does not address the issue of tenants and who should sign for a variance. The tenant is the one effected but has no legal standing for the property and may leave. The owner of the property is not the effected party in the residence but is the owner. Councilman Der will contact Attorney Gebo to ask for his opinion.

There have been complaints about the hours being worked by the tree removal crews for Copenhagen Wind. Supt. Mahar has contacted the company and made them aware of resident concerns.

Being as there was no further business before the Town of Denmark Town Board; Councilman Thoma made a motion to adjourn the meeting. His motion was seconded by Councilman Fazio.
