November 10, 2016

The regular monthly meeting of the Denmark Town Board was held November 10, 2016 at the Town Municipal Building. Supervisor Fleming called the meeting to order at 6:00pm with the Pledge of Allegiance.

**ASSESSOR REPORT:** Mr. Vargulick spoke to the Town Board about the Aged Exemption currently in place in the Town. He offered a recommendation that the sliding scale amounts be raised to allow our low income seniors to retain the benefit even if there is a slight adjustment in the amount they receive for Social Security. Discussion was held and it was noted that this exemption has not been adjusted in several years.

Councilman Thoma offered the following resolution; his resolution was seconded by Councilman Jones.

Resolution 34-2016: Town of Denmark Town Board authorizes that the Aged Exemption sliding scale be adjusted to increase each level of income \$500.00.

Assessor Vargulick also spoke to the Town Board about recent meetings he has attended in Lewis County. He has made adjustments to the railroad assessments to be more in line with other Lewis County Towns.

**WATER DISTRICT #1 UPDATE:** Mr. Cooper of Bernier, Carr and Associates spoke to the Town Board about the expansion plans. Currently he is reviewing the prior IMA's with the Village of Copenhagen to ensure that we are in compliance. It may be necessary to meet with the Village Trustee's to negotiate the needed language for the expanded district. Discussion was held on the timeline for funding. Supervisor Fleming is currently reviewing and preparing to sign paperwork for the Local Government Efficiency Grant monies. Mr. Cooper left the meeting at 6:15pm.

**SUPERVISOR'S REPORT:** Discussion was held on the current Emergency Order for Water District 1. Based on the fact that the Village plans to continue their Emergency Order Councilman Fazio offered the following resolution which was seconded by Councilman Jones.

Resolution 35-2016: Emergency Order for Water District #1

WHEREAS, the Town of Denmark Town Board on October 27, 2016 declared a State Emergency for mandatory conservation of water provided by the Town of Denmark Water District #1 users due to the lack of water supply being at an all-time low; and WHEREAS, the declaration of a State of Emergency pursuant to Section 24 of the Executive of the State of New York must be

renewed every five days, unless authorized by the Town Board by resolution to extend the declaration to every thirty (30) days; and

WHEREAS, it is more cost effective and efficiency of staff, to have the emergency declaration extended to thirty (30) days; Now, Therefore, Be It,

RESOLVED, that the Town Board of the Town of Denmark does hereby declare a State of Emergency for mandatory conservation of water provided by the Town of Denmark Water District #1 users due to the lack of water supply being at an all-time low; effective November 26, 2016 and

It is further,

RESOLVED, that such State of Emergency may be renewed every thirty (30) days until the water emergency can be lifted. Vote recorded as follows:

#### Resolution 35-2016 adopted November 10, 2016.

Discussion was held on the Zoning Applications that have been received from Copenhagen Wind. They have submitted 40 permits at this time. They paid the fees in a check for \$41,000.00, this included an overpayment of \$1000.00 that the Clerk will be refunding. ZEO Woodruff will be reviewing each permit and speaking to the landowners. He will be measuring the distances of the setbacks for each tower to ensure that they are in compliance with Town of Denmark Law. Driveway applications will be monitored and signed by Supt. Mahar. Discussion was held on the waiver process for structures within the project and on the Host Agreement payment timeline.

Discussion was held on ZBA member Robert Harding. Clerk Greene has tried to contact Mr. Harding throughout the fall for training opportunities by phone and mail. Neither method has been successful. Mr. Haggett of the ZBA has also tried to reach out to Mr. Harding with no results. Mr. Harding's home is now for sale and it is believed that he has left the Town of Denmark. At the conclusion of those Public Hearings another will be held for the purpose of considering a Local Law to place a moratorium for a period of six (6) months on applications or proceedings of application for Solar Energy Equipment / Systems to allow the Town Board to consider and implement sufficient regulations. Any person may be heard in favor or against any item or items therein contained. Any written comments must be submitted to the Town Clerk prior to that time and date for them to be presented to the Town Board at the time of the public hearing. Any persons requiring special accommodations to attend and participate in such public hearing should notify the Town Clerk prior to the hearing. #### Resolution 37-2016: Adoption of the Town of Denmark 2017 Fire Contracts

THIS AGREEMENT, made effective January 1, 2017, between the TOWN OF DENMARK, Lewis County, New York, party of the first part, herein after called the "Town", and the COPENHAGEN FIRE DEPARTMENT, INC., a corporation duly organized and existing under the laws of the State of New York, the VILLAGE OF COPENHAGEN and the VILLAGE OF CASTORLAND, municipal corporations situated in Lewis County, New York, and the VILLAGE OF WEST CARTHAGE, a municipal corporation situated in Jefferson County, New York, and duly organized and existing under the Laws of the State of New York, all the parties of the second part, herein after called the "Contractors".

WITNESSETH:

and

WHEREAS, there has been duly established in said Town of Denmark a fire protection district known as "DENMARK FIRE PROTECTION DISTRICT", hereinafter called the "District", embracing all the territory in said Town outside the boundaries of the incorporated Villages therein; and

WHEREAS, following a public hearing held on November 10, 2016 the Town duly authorized a contract with the Contractors for fire protection in the District;

WHEREAS, this Contract has been duly authorized by the Contractors.

NOW, THEREFORE, the Town of Denmark does hereby contract with the Contractors to furnish fire protection for the District and the Contractors agree to furnish fire protection as follows:

The District shall be divided into three (3) zones as set forth on the annexed map, which is hereby incorporated in and made a part of this Agreement, said zones being designated by numerals I, II, and III. Copenhagen Fire Department, Inc. and the Village of Copenhagen in the case of Zone I. The Village of Castorland in case of Zone II, and the Village of West Carthage in case of Zone III, shall during the period of this agreement, be subject to call for attendance upon any fire occurring in the zone above assigned to it, and when notified of a fire therein shall respond and attend upon the fire with all possible speed and with suitable equipment and personnel, and shall proceed diligently to effect the extinguishment of the fire and the saving of life and property in connection therewith.

Each of said Contractors shall also be subject to call for attendance upon any fire occurring in either of the Zones not assigned to it in Paragraph 1 above for purpose of assisting the Contractor which said Zone is assigned whenever such assistance is deemed necessary or advisable. This term of this agreement shall be for one (1) year, commencing January 1, 2017 and ending December 31, 2017.

In consideration of furnishing such fire protection, the Contractors shall, for the term of this agreement, receive as follows, and the Town agrees to pay the same on or by February 15, 2017, to wit:

VILLAGE OF WEST CARTHAGE \$ 8,750.00 VILLAGE OF COPENHAGEN & COPENHAGEN FIRE DEPARTMENT, INC. \$22,000.00 VILLAGE OF CASTORLAND \$22,000.00

All monies to be paid under any provision of this agreement shall be a charge upon the District to be assessed and levied upon taxable property of the District and collected with the Town Taxes.

IN WITNESS WHEREOF, the Town of Denmark has caused these presents to be signed by its Supervisor duly authorized to do so; Copenhagen Fire Department, Inc. has caused these presents to be signed by its duly authorized officer; the Village of Copenhagen has caused these presents to be signed by its Mayor; the Village of Castorland has caused these presents to be signed by its Mayor, and the Village of West Carthage has caused these presents to be signed by its Mayor, duly authorized to do so, the day and year first above written.

Councilman Fazio asked why the Town of Denmark needs to do this. Councilman Der responded that it would allow time for the Town to address the issue in its Zoning Law.

Councilman Der offered a Resolution that the Town of Denmark Town Board adopt Local Law 2-2016 - Six (6) Month Solar Moratorium as follows, his motion was seconded by Councilman Fazio.

#### Resolution 38-2016: Adoption of Local Law No. 2 of the year 2016 - Six (6) Month Solar Moratorium

Article 1. - Statement of Authority. The Town Board of the Town of Denmark, pursuant to the authority granted it under Article 16 of the Town Law and Sections 10 and 20 of the Municipal Home Rule Law of the State of New York, hereby enacts as follows:

Article 2. - Statement of Purpose and Findings. The Town Board of the Town of Denmark has been made aware of interest in Solar Energy Equipment/Systems desiring to locate in the area. Currently, the Town of Denmark Code does not contain provisions for regulation of such facilities. It is the purpose of this local law to establish a moratorium for a period of six months on applications or proceedings of applications for Solar Energy Equipment/Systems allow the Town Board to consider and implement sufficient regulations.

Article 3. - Enactment. The Town Board of the Town of Denmark does hereby enact as follows:

Section 1. Definitions

Solar Energy Equipment/System - Solar collectors, controls, energy storage devices, heat pumps, heat exchangers, and other materials, hardware or equipment necessary to the process by which solar radiation is collected, converted into another form of energy, stored, protected from unnecessary dissipation and distributed. Solar systems include solar thermal, photovoltaic and concentrated solar.

Section 2.

Commencing with the effective date of this local law and for a period of six (6) months thereafter, no person shall be allowed a permit to site or locate a Solar Energy Equipment/Systems as defined in this law within the Town of Denmark nor shall any application for such a permit be processed.

Article 4. - Severability. If any part of this Chapter shall be found to be void, voidable, or unenforceable for any reason whatsoever, it shall not affect the validity or enforceability of any remaining section or provision of this Chapter.

Article 5. - Effective Date. This local law shall take effect immediately upon filing with the Secretary of State.
