October 10, 2016: October 2016 - Regular Meeting

October 10, 2016

The regular monthly meeting of the Denmark Town Board was held October 10, 2016 at the Town Municipal Building. Supervisor Fleming called the meeting to order at 6:00pm with the announcement that the meeting would be recorded digitally followed by the Pledge of Allegiance.

Supervisor Fleming asked if any of the public present would like to speak. No comments were made.

Councilman Fazio made a motion to approve the amended agenda prepared by Deputy Clerk Souva. The motion was seconded by Councilman Der.

Mr. Gebo provided direction on several matters.

Due to the Village of Copenhagen's all time low water levels, a Resolution for the State of Emergency renewal to be extended to 30 day increments was drafted. Supt Mahar had stated the village had found a possible electrical issue in the wells that may have resulted in water levels being misread. Water is still being hauled in from West Carthage. Discussion was held and decision made not to extend the Town's order.

Mr. Gebo had nothing to add for the Offer of Purchase between Town of Denmark and Carroll Farms, LLC.

Copenhagen Wind Cultural Mitigation agreement was discussed. The Town Board has concerns over allocation of funds. The Town Board would like to see more dedicated to cemeteries and less for school programs. It was also discussed that Wind Power Generating Facility Zoning permits were necessary before they can proceed with clearing trees as this was part of the conditions for approval. Discussion was held on the budgeted funds for Riverside Cemetery. Mr. Gebo stated there are specific provisions in town law to keep cemeteries from being abandoned and having town assume responsibility for them. Mr. Gebo suggested a letter of intent stating funds are for specific use of operating expenses. Councilman Der asked why this wouldn't also apply to the Lewis County Humane Society and their need for upgrading dog kennels. Discussion held. Mr. Gebo stated since the Town already has a contract with the Humane Society, the contract could be amended to include monies toward capital expenses and operating costs.

Last month, the Village of West Carthage Solar Law was discussed. Mr. Gebo had reviewed them and offered comments which were provided to the Town Board in this month's board packet. Mr. Gebo advised they could adopt them now or have a moratorium. Councilman Jones asked if farms are exempt. Mr. Gebo responded that the regulations could not be overly restrictive due to Right to Farm laws. Discussion was held.

Local Law to override the Tax Levy was discussed and Mr. Gebo advised to override if necessary.

Update on Water District Project- Matt Cooper of Bernier, Carr and Associates and Mr. Gebo provided updates on Water District #1 Extension project. Mr. Gebo's office received revised numbers from Rachel Bernat of Bernier, Carr and Associates indicating an increase in bonds from \$2,500,000 to \$2,700,000. This is due to additional users and additional costs relative to the tank portion of the project. Discussion was held on the procedure for calculating the average costs.

Mr. Cooper stated the commitment letter had been sent in and the next step will be to close on the short term financing. Discussion was held on what qualifies as reimbursable expenses. This would include expenses like those from BCA, the purchase of the land for the storage tank and other previously incurred charges. The monies from the Shared Services Grant can be utilized to pay these bills. Mrs. Fleming raised concern about the bill from BCA on the current water abstract in the amount of \$64,365.33; the Town of Denmark Water District currently does not have the funds available to pay this expense. Mr. Cooper responded that the bill could be held until funding from the grant becomes available.

The finals maps of the Water District #1 Expansion were made available to the Town Board and discussed.

Mr. Gebo exited the meeting at 6:16 pm.

Councilman Der expressed concern about the proposed lateral line going to Donald (Biff) Green's residence. The lateral line will go from the end of the Village's main, across a parcel owned by Phil Eggleston and onto Mr. Green's property. The parcel owned by Mr. Eggleston will not be charged an EDU and is not part of the water district expansion because the line will be a lateral and not a main. If in the future there is a desire to include this parcel, it would have to be done as part of another expansion. It could not simply be added due to provisions within the law.

Discussion was held on the timeframe for the Public Hearing for Water District #1 Extension and Mr. Cooper stated that financing was dependent on that timeline.

Councilman Fazio offered the following:

WHEREAS, the Town Board has also received a long environmental assessment form for such project and has completed environmental review of such project, and

WHEREAS, pursuant Article 12-a of the Town Law a public hearing is necessary on the extension of the District, now, therefore, be it

RESOLVED the Town Board of the Town of Denmark does hereby set October 27, 2016 at 6 p.m. at the Town of Denmark Offices as the date, time and place of the public hearing on the proposed extension of Water District #1 in accordance with the map, plan and report on file with the Town Clerk, and as further described on Exhibit "A" annexed hereto, be it further

RESOLVED, that the Town Clerk is directed to publish and post a notice of such public hearing as required by Article 12-a of the Town Law indicating among other things that the maximum capital cost to be expended on such project is Two Million Seven Hundred Thousand and No/100 Dollars (\$2,700,000) and anticipated to be eligible for New York State Government Efficiency grant, EFC-DWSRF loans and grants, and/or Serial Bonds or a Statutory Installment Bond. That the cost for typical user, based upon such map plan and report for the proposed extension Water District #1 is:

Resolution 28-2016: WHEREAS, the Town of Denmark adopted a bond resolution on March 14, 2016 in the amount of \$2,500,000 for its Water District #1, and

WHEREAS, the Town of Denmark has received from its engineers a revised map, plan and report extending Water District #1 with additional users and additional costs relative to the tank portion of the project, and

WHEREAS, as a result it is necessary to modify the prior bond resolution as set forth below:

AMENDED BOND RESOLUTION DATED OCTOBER 10, 2016

A RESOLUTION AUTHORIZING THE ISSUANCE OF SERIAL BONDS OR A STATUTORY INSTALLMENT BOND, IN THE TOWN OF DENMARK IN AN AMOUNT NOT TO EXCEED \$2,700,000, THE PROCEEDS OF WHICH ARE TO BE USED FOR THE CONSTRUCTION OF A NEW WATER DISTRIBUTION SYSTEM INCLUDING WATER MAINS, STORAGE TANK, SERVICE LATERALS, FIRE HYDRANTS AND VALVES AND OTHER APPURTENANT FEATURES AND THE EXTENSION OF THE TOWN OF DENMARK WATER DISTRICT #1.

NOW, THEREFORE,

BE IT RESOLVED, by the Town Board of the Town of Denmark, Lewis County, New York, as follows:

Section 1. The construction of a new water distribution system and the extension to what is known as Water District #1, including water mains, storage tank, service laterals, fire hydrants and valves and other appurtenant features (hereafter, the specific

<u>objects and purposes</u>) is in the interest of the citizens of the Town of Denmark. The estimated cost of the installation the <u>specific objects and purposes for said District as determined by the engineers hired by the Town for such purposes is \$2,700,000. This is an increase of \$200,000 of a bond resolution adopted on March 14, 2016.</u>

Section 2. It is hereby determined that the period of probable usefulness of the aforesaid specific objects and purposes is forty (40) years, pursuant to subdivision 1 of paragraph (a) of section 11.00 of the Local Finance Law. It is further determined that no down payment is required pursuant to Section 107(d)(3)(a) of the Local Finance Law.

Section 3. The plan for the financing of such estimated cost is Serial Bonds and/or Statutory Installment Bonds and it is anticipated the Water District will be eligible for New York State Government Efficiency grant, EFC-DWSRF loans and grants, not exceeding \$2,700,000 for the specific objects and purposes and the Town hereby authorized to be issued therefore, pursuant to the Local Finance Law, for a period in excess of five (5) years.

Section 4. The faith and credit of said Town of Denmark, Lewis County, New York are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall become due and payable. Annual water rents shall be made in each year

sufficient to pay the principal of and interest on such bonds becoming due and payable in such year.

Section 5. All other matters, except as provided herein relating to such bonds, including determining whether to issue such bonds having substantially level or declining annual debt service and all matters related thereto, prescribing whether to manual or facsimile signatures shall appear on said bonds, prescribing the method for the recording of ownership of said bonds, appointing the fiscal agent or agents for said bonds, providing for the printing and delivery of said bonds (and if said bond are to be executed in the name of the Town by the facsimile signature of its Town Supervisor), including the consolidation with other issues, shall be determined by the Town Supervisor. It is hereby determined that it is to the financial advantage of the Town not to impose and collect from registered owners of such bonds any charges for mailing, shipping and insuring bonds transferred or exchanged by the fiscal agent, and, accordingly, pursuant to paragraph c of Section 70.00 of the Local Finance Law, no such charges shall be so collected by the fiscal agent. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law and shall otherwise be in such form and contain such recitals in addition to those required by Section 52.00 of the Local Finance Law, as the Town Supervisor shall determine.

Section 6. The validity of such bonds and bond anticipation notes may be contested only if:

- (1) Such obligations are authorized for an object or purpose for which said Town is not authorized to expend money, or
- (2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with, and an action, suit, or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication, or
- (3) Such obligations are authorized in violation of the provisions of the Constitution.

Section 7. Upon this resolution taking effect, the same be published in full in the Watertown Daily Times, the official newspaper of said Town for such purpose, together with a notice of the Town Clerk in substantially the form provided in Section 81.00 of the Local Finance Law.

Section 8. This resolution is subject to permissive referendum, pursuant to Section 35.00 of the Local Finance Law.

Section 9. This resolution shall constitute a statement of official intent for the purposes of Treasury Regulations Section

1.150-2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

On October 10, 2016 the Town Board of the Town of Denmark passed an Amended Bond Resolution authorizing the issuance of Serial Bonds or a Statutory Installment Bond not exceeding \$2,700,000 for extension of Water District #1 and the construction of a new water distribution system including water mains, water storage tank, service laterals, fire hydrants and valves, and other appurtenant features to be known as the Town of Denmark Route 12 Water District. The probable usefulness of the aforesaid construction is forty (40) years, pursuant to subdivision 1 of paragraph (a) of section 11.00 of the Local Finance Law. A full text of the resolution is available for inspection at the Town of offices, during normal business hours.

The validity of the obligations authorized by such resolution may be hereafter contested only if such obligations were authorized for an object or purpose for which the Town of Denmark is not authorized to expend money or if the provisions of law, which should have been complied with as of the date of publication of this notice were not substantially complied with, and an action, suit, or proceeding contesting such validity is commenced within twenty days of the date of publication of this notice, or such obligations were authorized in violation of the provisions of the Constitution.

Local Law No. ____1

A local law A Local Law to Override the Tax Levy Limit Established in General Municipal Law 3-c

Be it enacted by the <u>Town Board</u> of the Town of Denmark as follows:

Section 1. Legislative Intent. It is the intent of this Local Law to override the limit on the amount of real property taxes that may be levied by the Town of Denmark pursuant to General Municipal Law Section 3-c, and to allow the Town of Denmark to adopt a budget for the fiscal year 2015 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law Section 3-c. **Section 2. Authority.** This Local Law is adopted pursuant to subdivision 5 of General Municipal Law Section 3-c, which expressly authorizes the Town Board to override the tax levy limit by the adoption of a Local Law approved by vote of sixty percent (60%) of the Town Board.

<u>Section 3. Tax Levy Limit Override.</u> The Town Board of the Town of Denmark, Lewis County is hereby authorized to adopt a budget for the fiscal year 2017 that requires a real property tax levy increase of the amount otherwise proscribed in General Municipal Law Section 3-c.

Section 4. Severability. If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm, or corporation, or circumstance, shall be adjusted by any Court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm, or corporation, or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective Date. This law shall be effective upon filing with the Secretary of State.

ASSESSOR REPORT: Mr. Vargulick spoke to the Town Board about the history of the Town of Champion and the Town of Denmark jointly entering into the NYS Tax Cap Program. Originally this program provided additional funding for towns that made an effort to stay at 100% equalization. The towns had to remain at the same levels of assessment. Assessor Vargulick has been able to maintain this in the Towns of Champion and Denmark. The state stopped providing the additional funding as they ran into their own budgetary issues. At this point, Assessor Vargulick has been advised by the state that there is no financially penalty if the towns withdraw from the Tax Cap Program. There is also no benefit to leaving the program. At this time Assessor Vargulick intends to remain at 100% equalization within the Town of Denmark.

Assessor Vargulick also plans to meet Attorney Gebo about lawsuit filed against Town from WGS for their property assessment.

ZONING AND PLANNING: Town Board members were provided with copies of the September Zoning Report and the minutes of the September 22, 2016 Planning Board meeting in the board packet.

OLD BUSINESS:

Discussion was held again on the proposed Solar Laws. Councilman Fazio made a motion that the Town of Denmark hold a Public Hearing for the consideration of a proposed local law 2-2016 for a six (6) month moratorium on Solar Energy Equipment/Systems installed within the town. The Public Hearing to be November 10, 2016 at 7:00pm and would run concurrently with the Fire Contracts and Proposed Budget. Councilman Der seconded the motion.

HIGHWAY SUPT. REPORT:

Supt. Mahar updated the Town Board on recent activities of the department. He is waiting on parts for the tractor to mow roadsides. They have replaced culvert and blacktopped end of Old State Road from State Route 26 to the 2nd driveway of the second house down. One of the new plows is going to be on display at the Hard Hats Vendor Show in Syracuse. The town will receive an apron chain and rear sprocket for this. They have built a new rack out of used beams for screening sand for the plows.

Discussion was held regarding a Highway Dept. employee that will be going out on disability with FMLA for approximately 5 weeks. This will leave them one man short and after consulting with the union, Supt. Mahar recommends hiring Randy Harris on an as needed basis to fill in. This would allow for coverage while also eliminating the need to add a new full time employee that would be eligible for health insurance after 180 days.

OTHER BUSINESS:

More discussion held about the Copenhagen Wind project. Supt. Mahar said they are planning to start clearing trees and building roads starting next week but have not obtained necessary site permits and still need road agreement. Once the road agreement is here, it will need to be reviewed by Supt. Mahar and Dave Becker from County. Supt. Mahar will be contacting Mr. Woodruff about permits. Councilman Der will be contacting NYS SHIPPO to see if allocations for the Cultural Mitigation can be readjusted.

Councilman Der made a motion to have Supervisor Fleming sign the road agreement, after approval from Supt. Mahar. The motion was seconded by Supervisor Fleming.
