

Supervisor's Report: Supervisor Fleming asked Matt Cooper of Barton & Loguidice for an update on Water District #1. Mr. Cooper provided the following information to the Town Board:



Discussion was held on the impacts of Hurricane Harvey on Texas and its ability to produce the resin for HDPE. Mr. Cooper suggested that waiting until prices stabilize may be in the projects financial interest. After discussion Councilman Fazio made a motion that Barton & Loguidice notify all bidders for the expansion of Town of Denmark Water District #1 that the bid has been cancelled. Budget Officer Report:

Mrs. Fleming provided the Town Board with her August 2017 Report, a copy of a settlement check from Verizon Wireless for \$0.60 and the August 2017 Financial Report. Discussion was held on the Water District Capital Fund Abstract #5, Claims 8-9 Total \$1,375.32 that the Town Board approved for payment. She noted that there are not enough funds in the account to pay the bills as directed by the Town Board.

Discussion was briefly held on the check the Town received in the amount of \$93,710.30 for the reimbursement of Water District #1 expenses. Councilman Der noted that the check should be deposited into the Water District Expansion account.

Public Comment: Judy and Ben Colton of the Volunteer Transportation Center, Inc spoke to the Town Board about that organization and the work they do. The group has requested that the Town allocate budget monies in 2018 to support the agency.

Jerry Wichelns reported that the construction of the Copenhagen Wind has begun. Supt. Mahar noted that he has met with the developer but has not yet received the project schedule.

Dan Hirschey asked the Town Board about the resurfacing of Ridge Road. Supt. Mahar reported that if funds are available it will be crack sealed this year. Mr. Hirschey also inquired as to the procedure to reduce the speed limit on the Ridge Road. Supt. Mahar explained that a letter must be submitted to the Town Board who then asks Lewis County who in turn would request the State conduct a study.

Jerry Wichelns exited the meeting at 7:08pm.

Assessor's Report: Mr. Vargulick plans to do a town wide revaluation next year. He will be replacing his laptop this year. Discussion was held on breaking the CAP agreement with the Town of Champion. Mr. Vargulick will be attending the State conference in October. Councilman Jones asked about the WGS lawsuit. Mr. Vargulick explained that Attorney Gebo has requested more information from WGS.

Councilman Fazio exited the meeting at 7:21pm, returns at 7:24pm.

Discussion was held on the bill that the Town of Denmark has received from Lewis County for the 2018 Workman's Compensation program. Lewis County has informed the Town of a 1962 opinion of the NYS Comptroller (#63-755) that concludes a Town is responsible for coverage of firefighters within the town, including members of a village fire department. Based on that the Town of Denmark would pay as follows:

20% Property Valuation \$ 8,554.00 30% Payroll \$ 3,162.00

50% Experience \$13,526.00 Copenhagen Firefighter portion

\$ 30.00 Castorland Firefighter protection

\$ 1,290.00 Town Highway portion

Total \$26,562.00

This is a very significant increase due to the inclusion of the firefighters. The Villages have been paying this, the departments are Village Departments not Town Departments. Discussion was held. Supervisor Fleming will contact other Lewis County Towns to see how they are responding.

Highway Report: Supt. Mahar reported that shoulders and chip sealing will be the next projects undertaken. He also brought to the Town Board's attention that they may want to consider changing the name of Old State Road. Concern over the use of common names in addresses has developed. There are several Old State Roads all over the county and confusion in the 911 system and in mail are becoming more common. Discussion was held.

Supt. Mahar will be attending the fall highway school in Ellicottville, NY.

Supervisor Fleming made a motion to pay for the expenses of Supt. Mahar conference. His motion was seconded by Councilman Der.
