We reviewed your letter last evening. Last October the board asked who was going to contact the landowners and provide feedback. Supervisor Der responded he would reply to attendees. We as a board have been under the impression that this issue has been addressed.

I know I forwarded a copy of the resolution that was passed in 2014 that allowed "all" wind towers to produce 50 dbs. to Mr. Kiernan at his request. I have included a copy of the resolution, Supervisor Der said he had provided this previously.

Regarding what has been received or provided to EDF, there has no exchange of data. They will not provide the Town with anymore than they provided the landowners. Regarding my correspondence with Joon Lee, as the minutes state, there has been no correspondence.

We addressed the landowners who have outstanding complaints at our meeting in September. Councilman Wadsworth and I stated the goal of the Town was to bring the parties involved together. We made it clear that we would step away from this issue, hoping the parties involved would work together to negotiate in good faith to resolve the issues outstanding. EDF has done everything we have requested: They conducted a noise level survey; they have offered to enter into settlement agreements and they've even flown to the Town to meet with you folks. Our position as the Town, is that the Wind Towers are not violating any local laws.

Your request for Joon Lee's "Superior" should be addressed to EDF, not the Town of Denmark.

This has been a learning experience for everyone involved. We don't see that there is any recourse for the Town to take. We can't change the local law governing the decibels, if we did the existing towers would be grandfathered.

It's our recommendation that you follow up with EDF on all future concerns.
