

The Town of Denmark regular monthly meeting was held 08.21.2023 at the Town of Denmark municipal building. The meeting was called to order at 6:00pm by Supervisor Scott Doyle. Councilwoman Rowsam then led those in attendance in reciting the pledge of allegiance.

Clerk Greene completed a roll call of the Town Board as follows:

Councilman Wadsworth made a motion, seconded by Councilman Fazio to accept the minutes of 07.17.2023 prepared by Town Clerk Prudence Greene. Vote recorded as 5 aye and 0 no.

Councilman Fazio made a motion, seconded by Councilman Wadsworth, to accept the agenda for tonight's meeting. Vote recorded as 5 aye and 0 no.

Rob Company and A.J. Veith presented information about a potential solar array at the Town of Denmark facility. The array could either be mounted on the roof of the highway department or ground mounted on the property. The buildings are currently being serviced with single phase power and after reviewing the electrical uses / needs Mr. Company stated that this will still be adequate even with the possible addition of the heated sidewalk. If in the future the town were to install geothermal for heat the electrical system would need to be upgraded to 3 phase and the number of panels required would double.

Discussion was held on the advantages and disadvantages of roof vs. ground mounted solar arrays.

The roof system would be mounted on the ribs of the roof with S-5 clamps so there would be no penetration into the existing roof. A roof mounted system would require installation of emergency shutoffs to be used in the event of electrical issues or fire for each module. The roof is relatively flat so it can easily be walked for installation and servicing if necessary.

Concern was raised about the additional weight being added to the current roofing system on the garage. The roof is already 20+ years old. The panels available are approximately 42" x 66" and weigh about 40lbs each, 220 panels would need to be installed. Mr. Company has reviewed the building plans for the garage roof and the weight load for the roof and feels installation on the roof should not be a problem. The roof is rated for 50 years, and the panel life is expected to be at least 25 years. They will need to be replaced at nearly the same time. The panels should still be functioning at 80% efficiency after 25 years as they experience a 0.5 degrade annually. The ridge installation system lifts the panels up and allows snow to blow off the actual roof and the panels also have protective effect on the material under them as they block the roof's exposure to the elements.

A ground mounted system makes servicing the panels simpler but would require some ground maintenance to keep weeds and vegetation overgrowth away from the panels. It is anticipated the ground mounted system will cost more, maybe up to \$50,000.00 more, due to the trenching and drilling that would be required to install it. A ground mounted system would be at risk of being hit by debris.

Concern was raised about the potential effects of sand and road salt on the panels. Sand and salt are picked up by the wind on a continual basis from the stock kept on hand by the highway department. Mr. Company explained the frames for the panels are aluminum, the panels are glass, and some plastic is also used in the framing. He has not seen issues with sand / salt causing corrosion at other installations. They may need to be cleaned periodically.

Supervisor Doyle provided information about our current usage and electrical costs. In 2021 the town used 60432 kWh and paid \$8,835.41. In 2022 the usage was 57965 kWh for a cost of \$13,088.75. Based on current prices per kWh and estimated usage this year we may pay approximately \$15,850.75. If a heated sidewalk is installed in front of the office building it would add an expected 10,000 kWh annually, further increasing the cost

for electricity. If this money were applied to paying the local share of a solar array the payback would be estimated to be 7 – 11 years.

Supervisor Doyle explained that resolutions by the Town Board were needed to move forward with an RFP (Request For Proposal) and another would be needed to allow St. Lawrence Engineering to apply on the town's behalf for NYSERDA grant money.

Supervisor Doyle offered the following resolution for adoption, seconded by Councilman Jones as follows:

Resolution 93 of 2023: NYSERDA Application for potential solar project

The Town of Denmark Town Board hereby authorizes Fourth Coast Inc to apply to NYSERDA for grant monies for a potential solar project to produce the power used by the Town of Denmark offices and highway department.

Supt. Of Highways Mahar expressed his concerns and asked what the wind rating was for the roof array. Mr. Company stated they are rated for winds up to 110 mph.

Mr. Company explained that either a roof or ground mount system would supply the power needed for the facility but costs for installation will be higher for the ground mount system. No batteries would be needed to store the power, excess power generated in the summer would be directed into the grid and used by National Grid and when less power is produced in the winter the town would pull power from the grid.

Supervisor Doyle offered the following resolution for adoption, seconded by Councilwoman Rowsam as follows:

The Town of Denmark Town Board does hereby authorize St. Lawrence Engineering DPC to develop and advertise an RFP (Request For Proposals) for a qualified contractor to design / build a solar photovoltaic array to be either roof mounted on the highway department roof or installed at ground level to provide power to the offices and highway garage. RFP's will be accepted by the Town Clerk until 4pm on Thursday, 10.12.2023 and will be opened at the Town of Denmark regular monthly meeting held on Monday, 10.16.2023 at 6:05pm.

REPORTS OF DEPARTMENTS

Supervisor's Report:

North Country CPA/NYCLASS – Financials were provided to the Town Board prior to the meeting for review. Supervisor Doyle noted that the interest income earned YTD \$33,103.00 on the money invested with NYCLASS.

Supervisor Doyle discussed overages on several budget lines. The A5132.4 line is currently over budget by \$17,137.00 due to needed repairs to the boiler system, increased costs for replacement of 2 overhead doors on the highway garage, the purchase of an AED unit for the garage, and general increases in costs. A resolution is on the slate to transfer \$40,000.00 from fund balance to pay for the water system installation and general bills for the remainder of the year. Money was donated by the Larry Virkler Defibrillator Fund for the AED costs and a resolution to apply that money to the cost is also included on the slate. DA9050.8 and DB9050.8 were not funded this year and unemployment claims were made by former employees necessitating money being moved into those budget lines. A resolution on the slate will address this by utilizing \$900.00 from interest earned on invested money.

Supervisor Doyle addressed an issue in the 2023 adopted budget. The income from PILOT's was overstated by \$12,589.00. This will be corrected by resolution later in the fall.

Discussion was held on the Deputy Clerk salary line A1410.12. This year the position was authorized to receive holiday pay and 30 hours of vacation time in Resolution 1 of 2023. Town Clerk Greene recommends that \$1,728.00 be moved from the contractual line for her department to that salary line to cover that expense.

Councilman Wadsworth offered a resolution, seconded for adoption by Councilman Fazio as follows:

Supervisor Doyle has asked department heads, fire departments, Lewis County Search and Rescue, and NYMIR (insurance) to provide information to him by 09.01.2023.

The WQIP grant has been submitted for the proposed salt barn. If the grant is awarded Denmark would be responsible for approximately \$150,000 in costs but this would be offset in part an administrative credit and by use of the highway department for the grade and prep work and we may be able to use stone that the Town received from the wind project. The awards will be announced by the end of the year.

Supervisor Doyle spoke to the Town Board about potential benefits of developing a Comprehensive Plan. Most grant opportunities ask if the Town has a comprehensive plan, and our applications lose points because one has never been developed. The process would involve local officials, residents, engineers, and other outside agencies to develop a 10-year plan. Lewis County would contribute help from their Planning Department and \$6,000.00 toward the cost of developing the plan and it's estimated the Town would contribute around \$19,000.00. No action taken.

Discussion was held on a zoning applications approved by ZEO Gaines for a shed built on the Station Road beyond the railroad tracks and the addition on Widrick Truck and Diesel.

Scott Lawrence from North Country CPA's will attend the September regular meeting on 09.18.2023.

The Foreign Fire Tax money has been received. Total is \$2,447.53 and a resolution to split this amount equally between the 3 fire companies is on the slate of resolutions.

Town Clerks Report: Clerk Greene provided a copy of her monthly report for July to the Town Board prior to the meeting. The Town Board had no questions.

A letter from Atty Burrows dated 08.07.2023, Subject: Storage Battery Fires, was provided to the Town Board. The solar projects located in Denmark do not utilize battery storage, they are connected to the grid.

Clerk Greene supplied copies of the following reports to the Town Board: RACOG – monthly report, Dog Control Officer- no July activity, Zoning Officer – monthly report.

Superintendent of Highways & Special Districts: Supt. Mahar provided copies of his Budget Report, Voucher Report and an update on Highway Department activities including work being done chip sealing roads this week.

He asked the Town Board to consider issuing a replacement check for a claim made by LED Outfitters in January. The claim was processed as voucher 6 on the January 2023 Highway Abstract and a check was mailed but never received. This matter has been addressed by a proposed resolution on tonight's slate of resolutions.

Town Clerks Report continues: Town Clerk Greene provided the Town Board with the General, Water District 1, and Highway Abstracts prior to the meeting.

Discussion was held on equipment that the Clerk has asked to have declared surplus. A resolution is included on the slate for this declaration and another to allow for the destruction of old bank statements & deposit receipts 2002 – 2016.

Justice Hancock has asked for a resolution supporting his JCAP grant application for \$5,604.07. A proposed resolution of support is included on tonight's slate of resolutions.

Clerk Greene has prepared the NYSLRS resolution for those employees participating in the retirement system that are also 1-year appointees. A proposed resolution is included on tonight's slate of resolutions.

Old Business:

Supervisor Doyle reported that the Inner Connection Study has been completed by National Grid at no cost to the Town. Clerk Greene was asked to destroy the general fund check #13169 drafted to pay National Grid for the study and inform the accountants that the check will not be needed.

Discussion was held about RPTL 466a which authorizes a property tax exemption to volunteer firefighters and volunteer ambulance service workers if a taxing municipality adopts a local law. The draft law has been reviewed by Attorney Burrows and the Town can move forward if they wish but neither the Village of Copenhagen nor the Village of Castorland plan to adopt it at this time and Copenhagen Central School also seems to be disinclined to adopt it.

Discussion was held on the three new LED lights to be installed. Supt. Mahar has said his department can do the installation. 2 will be placed in the lower-level parking area and the other will be placed on the far side of the upper-level parking lot.

Supervisor Doyle provided information about a business being developed by Peter Myers Jr. of Watson. He is planning a business that would use green waste to produce charcoal briquettes. We would have to pay him to haul the green waste away.

New Business

Jeff Snyder, a 27-year employee of the Highway Department, has expressed interest in being appointed to the Highway Superintendent position after Superintendent Mahar retires. The appointment would be effective until someone is elected in the November 2024 election. Supervisor Doyle and Supt. Mahar have discussed this possible appointment and if made Mr. Snyder could begin shadowing Supt. Mahar later this year to prepare to assume the appointment until the election of a new Superintendent of Highways. Discussion was held and will be continued at the next regular meeting.

Mr. Snyder is not interested in being appointed as Supt. Of Special Districts and Supervisor Doyle has spoken to Richard Ross about that potential vacancy. Mr. Ross is currently the Village of Copenhagen's Water Supt. Discussion was held. A highway department employee, Dylan Smith, has also expressed interest. Discussion was held. Mr. Smith would need to attend the upcoming class offered by NYS Rural Water to attain his Grade D certification. Supt. Mahar suggested that the expense of the school could be billed to SW8310.4 – Water District Contractual. Councilwoman Rowsam stated her support of "promoting" from within. Supt. Mahar is willing to stay in the position until such time that a replacement is trained and named. Supt. Mahar also stated that he is willing to forgo the salary so it can be paid to Dylan Smith who can complete the necessary tasks under Supt. Mahar's license until Mr. Smith is licensed himself.

Councilman Wadsworth offered a resolution, seconded by Councilwoman Rowsam, as follows:

Resolution 96 of 2023 is adopted 08.21.2023

Discussion was held about holding a Town Board work session for development of the 2024 Town of Denmark budget. Supervisor Doyle made a motion, seconded for adoption by Councilman Jones, as follows:

The Town of Denmark Town Board will hold a work session on Thursday, September 7, 2023, at 5:30pm to develop the proposed 2024 Town of Denmark budget. Vote recorded as all ayes. Town Clerk Greene will provide notice to the media and post the information.

Discussion was held on the projected increase for the town's insurance policy through NYMIR. Supervisor Doyle asked the Town Board if they wished to put out an RFP for insurance. Discussion held. No action taken.

Supervisor Doyle discussed the new Community Bank "Muni" Division. Community Bank, N.A. would like to meet with Supervisor Doyle to discuss moving the money invested with NYCLASS back to Community Bank. Discussion was held. No action taken.

Discussion was held on a letter that the Sno-Pals Snowmobile Club would like the Supervisor to sign a letter for their annual application. A resolution to allow Supervisor Doyle to sign the letter is included on the slate of resolutions to be voted upon at the end of this meeting.

Discussion was held on the overgrowth inside the perimeter fencing at the Town's water tower located off County Route 194. Some small trees have grown inside the fence. Supt. Mahar will see that they are cut down. Supervisor Doyle provided a quote in the amount of \$300.00 from Millers Turf for vegetation control. A resolution to accept the quote is included on the slate of resolutions.

Supervisor Doyle discussed sending a letter to the Federal Service Transportation Board – regarding Lewis County's Rails to Trails proposal. The Towns of New Bremen and Lowville as well as the Village of Lowville have sent a letter of opposition to the Federal Transportation Board in an attempt to prevent Lewis County's Rails to Trails project. Discussion was held. Councilman Wadsworth made a motion, seconded by Councilman Fazio, to allow Supervisor Doyle to send a letter to the Federal Service Transportation Board stating the Town of Denmark's opposition to the proposed Lewis County's Rails to Trails project. Vote recorded as 5 ayes. Supervisor Doyle will send the letter.

Supervisor Doyle advised the Town Board that he has received the water rate from the Village of Copenhagen for 2024 and the information will be considered in developing the 2024 budget. The Denmark Water District will be billed \$7.45 per kgal in 2024.

Supervisor Doyle has received a contract from Jefferson County for Snow and Ice removal 2023 – 2024. Supervisor Doyle has asked the Jefferson County Attorney for language changes to make it more in line with the previous agreement and will provide it to the Town Board when the corrected copy is received.

Discussion was held on unused funds from GSPP Development Agreements that the Town entered into in August of 2021. The projects SWPPP plans were reviewed and approved by the Planning Board with the assistance of Barton & Loguidice. At this time all costs associated, both legal and engineering, have been paid for and \$29,596.15 remains of the original \$40,000.00. A resolution to refund the money has been included on the slate of resolutions.

Discussion was held on the estimate from MTL Design, Inc., dated 07.24.2023, for the repair of siding panels on the highway garage caused by the NYS DOT several years ago. The quote is in the amount of \$18,509.00 to remove, repair, and block bond the damaged panels. Supervisor Doyle has provided it to the NYS DOT so they can initiate the repair. Supt. Mahar noted that the contracts for the NYS DOT's use of the highway garage facility are 2 years in arrears.

Discussion was held on the recent use of Town of Denmark equipment for gravel delivery to the former Copenhagen Fire Department. Supt. Mahar has spoken to the employees responsible, and the matter has been handled internally. The Fire Department is no longer in a contract with the Town for fire protection so no town-owned equipment should be used to assist that group.
