

Minutes of Special Meeting 10.26.2023

The Town of Denmark held a special meeting on 10.26.2023 at the Town of Denmark municipal building. The following notice of the meeting was provided to the media, posted on the town website, posted in the three US Post Offices in the town:

The Town of Denmark Town Board will hold special meetings, on Wednesday, October 25, 2023, at 6pm and Thursday, October 26, 2023, at 6pm for the purpose of entering into executive sessions to conduct interviews of candidates for a potential appointment as Supt. Of Highways. The meeting will be held at the Town of Denmark municipal building located at 3707 Roberts Road, Carthage, NY 13619.

The meeting was called to order at 6:00pm by Supervisor Scott Doyle. Town Clerk Prudence Greene then led those in attendance in reciting the pledge of allegiance.

Clerk Greene completed a roll call of the Town Board as follows:

Jeff Snyder (present at 6:00pm, stays for Executive Session and exits Executive Session at 6:21pm)

The following statement was read aloud by Supervisor Doyle: "In accordance with our ethics policy, Mr. Jones will be participating in the interviews in an observatory role. While he will not be taking an active role with the interviews, the post interview discussion, or the vote to appoint, it is his responsibility and desire as a board member to observe and remain informed about the interview process and candidate selection as this is essential for ensuring transparency and accountability within our organization. "

Councilman Jones sat in the rear of the meeting room.

Councilman Wadsworth made a motion at 6:01pm, seconded by Councilman Fazio, to enter into an Executive Session for the purpose of conducting interviews of potential candidates for appointment to the position of Supt. Of Highways should a vacancy occur. Vote recorded as follows: 4 ayes, 0 no, Councilman Jones did not vote.

Clerk Greene exited the meeting at this time. Jeff Snyder was asked to remain in the Executive Session.

At 6:21pm Jeff Snyder exited the Executive Session and the meeting.

Councilman Wadsworth made a motion to exit the Executive Session and his motion was seconded by Councilwoman Rowsam. Vote recorded as follows: 4 ayes, 0 no, Councilman Jones did not vote.

The meeting resumed at 7:11pm and Clerk Greene reentered the meeting.

Discussion was held on the email to be sent to the candidates by the Town Clerk.

Councilman Fazio made a motion to adjourn the meeting. No action.

Supervisor Doyle requested that the Town Clerk notify him when the resignation is received.

Being as there was no further business before the Town Board Councilman Fazio made a motion, seconded by Councilman Wadsworth to adjourn the meeting. Vote recorded as follows: 4 ayes, 0 no, Councilman Jones does not vote.

Meeting adjourned at 7:17pm.
