An application has been duly made to the Board of the **Town of Denmark, County of Lewis,** New York, by **Spectrum Northeast, LLC**, an indirect subsidiary of Charter Communications, Inc. ("Charter"), a limited liability company organized and existing in good standing under the laws of State of Delaware doing business at 6005 Fair Lakes Rd, East Syracuse, NY 13057, for the approval of a renewal agreement for Charter's cable television franchise for fifteen (15) years commencing with the date of approval by the Public Service Commission.

- 1. Spectrum Northeast, LLC has substantially complied with the material terms and conditions of its existing franchise and with applicable law; and
- 2. Spectrum Northeast, LLC has the financial, legal, and technical ability to provide these services, facilities and equipment as set forth in its proposal attached; and
- 3. Spectrum Northeast, LLC can reasonably meet the future cable-related community needs and interests, taking into account the cost of meeting such needs and interests.

BE IT FURTHER RESOLVED that the Board of the **Town of Denmark** hereby grants the cable television franchise of Spectrum Northeast, LLC, and the **Town of Denmark** for fifteen (15) years commencing with the date of approval by the Public Service Commission and expiring fifteen (15) years hence.

BE IT FURTHER RESOLVED that the Board of the **Town of Denmark** hereby confirms acceptance of this franchise renewal agreement.

Effective immediately, it is agreed that Article 24 will be modified to reflect the compensation of a yearly stipend of \$1,550.00 to be paid to highway department employees trained and engaged in water district operations for the Town of Denmark, see attached for job description for water operator as provided by the town. In addition,

The Town currently has one employee trained as a water operator, though the town is willing to train a second employee, who would also be eligible for the stipend once he/she receives their license. The annual stipend will be prorated on a monthly basis in the event an employee does not serve a full twelve months as a water operator in each fiscal year. The changes covered in this MOU will be attached to the current contract and become a permanent part of Article 24 language.

In the event there are no members of the collective bargaining unit that are properly trained to complete the Water Operator duties, the Town of Denmark, to comply with Department of Health regulations, has the right to utilize outside personnel to complete the testing. In the event that outside personnel are utilized the Town will not be penalized for such instances.


