Supervisor Doyle informed that Planning Board Chair Kevin Gaines, does not have any concerns for the planning board to issue an exemption from local permitting.

Supervisor Doyle has received a letter from BCA, dated 4.11.2024, requesting the Town's permission to allow the Village of Copenhagen to be lead agency for the SEQR of their water infrastructure improvement project. The project will connect the village of Copenhagen to the Carthage/W. Carthage water supply. Supt. Mahar noted that DOH requires there to be two water sources, Clerk Greene agreed.

Supt. Mahar wonders if the Town will be able to add new customers to the new line? Supervisor Doyle offered that it is still too early to know, adding, there are 24 homes and barns in that area. The project will include fire hydrants for Fuller and Harris roads.

Supervisor Doyle advised the connection will be mutually beneficial for these villages in having a larger flow of water going through the line. It has yet to be determined if this line will be for transmission or distribution. Supervisor Doyle informs the Board that Town of Denmark has no financial responsibility to the project if it is a transmission line.

Councilmember Fazio voiced concerns that the Village of Copenhagen had just put money into the Woodbattle station fearing it will be abandoned. Councilmember Jones explained the village had received an estimate of \$700,000 to fix all problems there, but the Village had opted to rehab just the essentials, such as the roof and heating system costing \$130,000, being just a fraction of what it could have been. Discussion held.

Paul Shepard – RACOG introduced himself as an intern with RACOG, transitioning away from Ft. Drum. Mr. Shepard will be providing monthly updates and reports from RACOG. He reported the Economic Visioning Summit was a great success. There were 30 attendees, noting a few leaders of Lewis County providing some great information.

The next meeting will be May 30, 2024, survey results are expected back from Albany by then.

RACOG is engaging students in local government, as well as seeking public officials from local government to explain their specific role, how what they do impacts their community.

Chris Barboza – Tug Hill Commission is collecting data of regional traffic studies to see if a Regional Traffic Safety Plan would be worth developing. Chris will be sending out a survey for walkability, safety concerns, and grant opportunities for transportation and safety.

Supervisor Doyle added that the Town has requested a speed study on NYS Rt.26 from the County Line to Deer River.

Clerk Greene reported that Dog Control Officer, Lindsay Hess hit the ground running with calls on April 1st and has submitted her first report, April 1 through April 11, which was included in the meeting materials for the Boards information.

Clerk Greene informed the Town Board that the ZBA – Zoning Board of Appeals has received two applications for Special Use projects for proposed telecommunications (cellular) towers. The ZBA will be holding meetings, a public hearing and asking Lewis County to do a 239 L&M review for each project.

Supervisor Doyle added that he had received an email from New York State Historic Preservation Office giving notice to the town that this project has been brought to them to determine historic significance. Supervisor Doyle does not believe either site has any historical significance.

Supt. Mahar, a planning board member, suggested the Town Board consider amending the Zoning Law to increase the allowable height for structures. Discussion held.

Councilmember Jones made a motion for Supervisor Doyle to follow up with Attorney Burrows in drafting an amendment of the local zoning law, seconded by Councilmember Rowsam. Motion carried with a call of all Ayes.

Clerk Greene informed the Town Board she has received a letter from Sarah Wilder, requesting water hookup for a parcel she is in the process of purchasing. Clerk Greene added the current owners are paying a partial EDU fee for water lines running across the property.

Supervisor Doyle made a motion that he write a letter to the Village of Copenhagen requesting this new water customer be added to the line, seconded by Councilmember Jones. Motion carried with a call of all Ayes.

Discussion held.

Clerk Greene informed the Town Board that she has received approval from Village of Copenhagen after a similar quest made last month for Mr. Smykla who is planning to subdivide his property, allowing for a new home to be constructed, adding it to the water line.

Supt. Mahar advised; he would contact Mr. Smykla to develop a timeline for his water line hookup.

Superintendent of Highways & Special Districts - Superintendent Mahar

Supt. Mahar provided an update on his department's activities. State Hwy. is gone for the season. The salt shed has been relocated. NYS has no new budget yet.

Supt. Mahar advised he has begun interviewing new applicants for the vacancy in his department.

Supt. Mahar addressed a water violation, informing that he has not heard anything back yet from Mr. Curley. Supt. Mahar considers the lack of reply from Mr. Curley to be a dismissal of the violation.

Supt. Mahar advises he will schedule a time with Clerk Greene for Water letters and will be doing meter readings next week.
