1a: Issuance of Bills: Quarterly Collection

Water bills shall be issued quarterly. Water bills shall be addressed
to the tax billing address for the parcel.

WHEREAS, pursuant to the New York Environmental Quality Review Act, this Board has determined that the action is properly characterized as Type II under SEQRA, and no further environmental review is required.

3. The Supervisor for the Town of Denmark, and the Town Clerk, their respective agents and employees are hereby authorized to sign all documents and take all steps necessary to enact this legislation

1. This Legislation shall be filed with the New York State Department of State and with the Town Clerk of the Town of Denmark and shall become effective thereafter.
2. This Resolution shall take effect immediately.
